## **Century Trim**

## Limited Warranty: Century Trim CPVC (Cellular Polyvinyl Chloride) Trimboard Products

Subject to the terms and conditions stated herein, Asia Building Materials Limited (hereinafter "Supplier") warrants to the original consumer purchaser that each Century Trim CPVC Trimboard Product (hereafter "Century Trim" or "Product") as shipped, will be free from manufacturing defects that cause the Product to rot, corrode, delaminate, or excessively swell from moisture for a period of twenty-five (25) years from the date of original consumer purchase from an authorized Century Trim dealer. Each purchaser of the Product is responsible for following Supplier guidelines for installation, as well as determining the effectiveness, safety, and suitability of any particular use or application of the Product. Each Century Trim purchaser should consult local building and safety codes for specific requirements, as they may vary from area to area. This warranty may not be transferred or assigned.

## Additional Limitations - Conditions Not Covered by This Warranty

Supplier's liability under this Warranty applies to the original purchaser only and is limited exclusively to replacement of defective Century Trim Product or the issuance of a refund equal to the original cost of the Century Trim Product. In no event shall the Supplier be liable for labor, installation, re-installation, freight, taxes, or any other charge related to defective Century Trim Product. Supplier shall not be liable for any indirect, incidental, punitive, consequential, exemplary or other damages of any kind whatsoever, whether any such claim is based upon theories of contract, warranty, negligence, tort strict liability or otherwise. This Warranty does not cover and the Supplier is not liable for damage or failure of the Product as a result of one or more of the following: intentional or unintentional misuse of or damage to the Product; impacts of foreign objects; earthquake, flood, fire, lightning, hail, ice, tornado, hurricane, windstorm, or any other Acts of God; improper installation of the Product or its structural supports and accessories used in connection with, or not in strict adherence to Supplier's written installation instructions; movement, settlement, distortion, warping or cracking of the Product's structural supports or accessories used in connection therewith; physical abuse, vandalism, riot, insurrection, improper maintenance, use or incompatible accessories; or other products that cause a Product defect or failure to occur; pollution, acid rain, application of harmful chemicals or vapors applied to the Product; or ordinary and expected weathering due to exposure to the elements, which for warranty purposes is defined to be fading, chalking, or darkening of the surface of the Product due to exposure to ultraviolet light and extreme atmospheric conditions that are unique to and may vary in certain geographic locations. Asia Building Materials Limited shall have sole discretion in the determination of product suffering from normal weathering. This warranty does not cover painted finishings or coatings applied to the Product by the original purchaser or any third party. All claims under this Limited Warranty must be made within 90 days from the time the defect is discovered and while the Century Trim Product is in place. The original consumer purchaser shall provide the Supplier and its employees with a reasonable opportunity to inspect and test the Century Trim Product, its installation, and the environment in which the Product was used prior to removal so that the Supplier may determine what replacement, if any, may be needed. In the event that is determined a replacement is appropriate, the Supplier shall have the option of retaining all material that is replaced. If the Supplier replaces any material under this warranty, it may substitute other Century Trim products of comparable quality or price range in the event the initial product purchased has been discontinued or modified. Failure to comply with notice and inspection provisions shall void all warranties with regard to the Product. This Warranty may not be altered or amended except in a written instrument signed by the Supplier and Century Trim purchaser. No dealer or other person or entity is authorized by the Supplier to make statements or representations regarding the performance of Century Trim Products except as contained in this Warranty, and the Supplier shall not be bound by any such statements other than those contained herein.

THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LEIU OR ANY AND ALL OTHER APPLICABLE WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Some states do not permit limitations on the duration of implied warranties or exclusions or limitations of incidental or consequential damages. This warranty gives you specific legal rights. You may have other rights that vary from state to state.

## How to File a Warranty Claim
